Outcomes

TASK DESCRIPTION: The task has two parts of equal value.

Part A- ARTMAKING- You will be assessed on technical painting skills, resolution and conceptual strength. Additionally, you are required to submit your Visual Arts Process Diary, which should include any experimentation, research, and exploratory work you have undertaken.

Students are to create one painting appropriating a Modernist artwork & Visual Arts diary This work must:

- Appropriate the original painting, recontextualising the original
- Be an appropriation of a Modernist artwork
- Demonstrate an understanding of appropriation

Part B- Critical & Historical- Google Slide Presentation

Create a presentation that addresses the following points:

1. Explain Modernism and the Avant-garde:

- Provide a clear explanation of Modernism as an art movement.
- Describe the role of the Avant-garde in challenging artistic traditions.

2. Analyse Your Chosen Artist:

- Explain how your selected artist fits within the Modernist movement.
- Support your analysis with at least two of the artist's artworks.

3. Use Support Materials:

• Refer to scaffold and class resources to help develop your response (see scaffold at the end of this document).

Tips for success: Use a range of sources for your research. You can submit a draft for teacher feedback at least 1 week before the due date.

An insightful and nuanced explanation of the Avant-garde is included, highlighting its impact on challenging artistic traditions. Examples are described, analysed, and interpreted to an in-depth level, effectively supporting the information presented. All headings are comprehensively explored, and in-depth information is presented throughout. The presentation is highly engaging and exceptionally well-structured.	45 – 50
High • • •	The presentation demonstrates a well-developed knowledge of the life and art-making practice of the selected artist, showing a strong understanding of Modernism. The role of the Avant-garde is clearly explained, illustrating its influence on breaking traditional norms. Examples are clearly described and analysed, effectively supporting the key points. Most headings are explored in detail, and relevant information is presented clearly. The presentation is engaging and well-organized.	35 – 44

Critical & Historical Google Presentation Scaffold

Slide 1: Title Slide

- Title of the presentation
- Student name
- Chosen Modernist painting and artist

Slide 2: Introduction to Modernism

- Definition of Modernism: Briefly explain Modernism as an art movement (e.g., a break from tradition, experimentation, focus on innovation).
- Key Characteristics: Highlight at least three (e.g., abstraction, emphasis on materials, challenging conventions).
- Role of the Avant-garde: Define the term and explain how the Avant-garde pushed boundaries within Modernism.

Slide 3: The Chosen Artist within Modernism

- Artist Introduction: Name and brief background.
