#### Part 1 – Landforms and Processes (100-300 words)

In Part 1 you will choose one Australian landform and describe the geomorphic processes that formed it. You will hand in a report or slide show that includes:

A map showing the location of the landform

At least one photo of the landform

A written description of the landform and the processes that shaped it.

You may include diagrams along with your written description.

### Part 2 – Lake Mungo Archaeology Report (100-300 words)

In Part 2 you will describe the archaeological evidence at Lake Mungo in NSW and explain what it tells us about Aboriginal people's occupation of the site. You will hand in a written response that:

Describes some of the archaeological sources found at Lake Mungo

Explains what these sources tell us about the way Aboriginal people lived at Lake Mungo in the past.
