Principal's report: attached:

General Business

Paul proposed a motion requesting a statement from the P&C supporting the principal stance on the School strike for climate change. The P&C shares the principals concerns for child safety and supports her position. Seconded by Branca, passed unanimously.

Paul explained the (fair funding model). Promised by ALP in the upcoming election. This funding will translate to over \$1 million for this school. The school can decide how to spend this money e.g. employ teachers or whatever is deemed necessary which is great opportunity. At this stage both the Labor and Green's candidates fully support this fair funding model. Paul requesting Parents, community members to put pressure on all candidates to support this so as to secure more funding for the school.

Belinda explained that the school is the process of applying for cooler schools funding for air-conditioning for more of the rooms. Yeah.
